One thing I will be doing is handing over the <u>CPAG policy briefs</u>. These policy briefs are a roadmap across things like food, housing, health, and education- to ensure every child gets the basics.

This amazing work has been carried out pro bono by CPAG members and supporters - a group of highly regarded academics, researchers, policy makers and community activists. We will be reminding the Minister of the target to half child poverty by 2028 under the Child Poverty Reduction Act. We need to keep monitoring the numbers and stay accountable. Your thoughts on how we present this to the Minister are welcome.

And just back to joining as a member. The Annual General Meeting is coming up in a couple of weeks on 24th July here in Auckland.

As an incorporated society the AGM is where we present our accounts and report back to our members on the years highlights of research, education and advocacy. Joining as a member tells us you support this work.

Overcoming child poverty is the right and compassionate thing to do. I am grateful and thankful for your continued support.
