Carer Support and NASC assessments

[Carers NZ](#) has provided the following answers for families on Carer Support and NASC reviews:

CARER SUPPORT: Yes, you can use this to pay someone in your household for relief care; you can use it to pay someone aged 14+ (not 18+); and you can use it for relief care while you are working outside the home. In Auckland incorrect communication from the NASC confused some families. The system hasn't reverted to those old rules. Keep claiming as above even if you were given the wrong information. If in doubt, talk to the NASC.

NASCs **should not** tell you they are only allocating support for disabled people with high/complex needs. This is not government policy. You **should not** be told that there is a cap on Carer Support allocations. That's not how the policy works.

If this happened to you, please [message Carers NZ](#) as they are running point on these issues.

Some reviews and assessments have resulted in disabled people receiving **less support** than in the past. This is because allocations are being made consistent across New Zealand for similar needs. NASCs all have the authority to look at your individual situation – for example, there may be reasons why you need more support than the allocation given to others with similar needs. NASCs have been told they have to allocate within a finite budget in the current financial year to the end of June 2025. January advocacy

This year there were several legislative Bills coming into Select Committee that have potential to impact on our families in less-than-helpful ways. PVI drew on our position statements, key values, and constitution, as well as core documents like the Bill of Rights Act, the United Nations Convention on the Rights of Persons with Disabilities, New Zealand Disability Strategy, and Enabling Good Lives Principles in making the following submissions:




A new school year can bring new challenges. Below are a few useful education-related links:
